SENIOR DENTAL STUDENTS UNIVERSITY OF DETROIT MERCY SCHOOL OF DENTISTRY

Senior fourth year dental students will present interesting cases that they worked up during their junior year and are now in the process of active treatment. Twelve seminar groups each comprised of twelve students meet for presentations. The students present their cases revealing their successes, struggles and failures. Students discuss medical conditions, diagnosis and different options that could have been presented to a patient and what else they could possibly have done with the case. There are always good discussions after presentations. Most senior students are still working on their patients and most patients are still receiving treatment. While some patients may have left due to financial reasons, their cases are still interesting enough for the group to learn from them. Sometimes the students learn how they could have done things differently. Students select these cases because they offered a valuable lesson in treatment planning, patient care and obstacles to treatment.

- Case 1 (William) Unemployed person seeking dental care needs periodontal treatment and has an oral lesion requiring a biopsy.
- Case 3 (Ekbatani) Failing dental work that was done in a foreign country. Questionable prognosis and patient is adamant about retaining her teeth.
- Case 3 (Dapoz) Patient has received regular dental care throughout his life. He has teeth requiring extraction. Implants were presented as a treatment option.
- Case 4 (Falvo) Sixteen-year-old patient with Amelogenisis Imperfecta and high caries rate. Complicating factors to patient care are transportation, finances, and communication barriers. The goal is to stabilize the patient until age twenty-one for full mouth reconstruction.
