PROPOSED CHANGES - DDCC CONSTITUTION

The Board of the Detroit Dental Clinic Club, after much deliberation, recommends that it is in the best interest of the DDCC to broaden our ability to induct new members. The following changes to our Constitution are proposed by the Board and will be voted on at our All Section May 15, 2014 Annual meeting by our members:

- Whereas, in the past prospective new members have come to the parent body Board of Governors of the DDCC through individual DDCC Sections,
- Whereas, most of the DDCC Sections have diminished activity or have become inactive, and the main activity of the DDCC has been through the general body meetings,
- Whereas, the Board of the DDCC has sought avenues to expedite the process of membership
- Therefore, the Board of Governors of the DDCC propose that the Constitution be revised to allow a prospective member to apply directly to the general body of the DDCC and the Board of Governors may confer membership to a qualified candidate without first going through a DDCC Section. It is proposed that the Constitution be revised as follows:

Constitution
Article V - Membership,
Section 2 - Active Members

Active Members shall be chosen in the following manner:

- a. A member of the American Dental Association or the Canadian Dental Association who shall have participated as an Invitational Member in the activities of the Club for a period of one year or more may be nominated for Active Membership by three-fourths vote of the Active Members of the involved Section.
- b. Election to Active membership must be by a three-fourths vote of the Board of Governors.
- c. A dentist of recognized ability that meets the requirements for membership may be elected by a three-fourths vote of the Board of Governors provided that a majority of the members in said Section approve.

PROPOSED CHANGES - DDCC BY LAWS

The Board of Governors proposes the following revisions to update the By-Laws of the DDCC to accurately reflect the operation of the office of Secretary and current dues of \$75.00 per year for Active Members. The following changes to our By Laws are proposed by the Board and will be voted on at our All Section May 15, 2014 Annual meeting by our members:

BY-LAWS

Chapter I - Duties Of Officers

Section 3 – Secretary

- a. The Secretary shall keep minutes of all meetings. These minutes shall be read at the regular meetings of the Club. At the end of his term of office, the Secretary shall have these minutes, along with the annual reports of the Section Directors microfilmed, and the negatives deposited with University Microfilms, Ann Arbor (who have the microfilms of our previous records for safekeeping). The minutes will then be placed as a permanent record in the Secretary's book.
- b. He shall act as custodian for all minutes, correspondence, documents and all other hereditaments of his office and deliver these at the expiration of his term of office to his successor.
- c. He shall send notices to all members of the time and place of meetings.

Chapter VI - Funds

Section 2

Annual dues for active members shall be <u>40</u>–<u>\$75 dollars per year</u> unless Remitted in whole or in part by a three-fourths vote of the Governing Body.
